CONTRACTOR REGISTRATION.....\$100.00

HOT WATER TANKS (REPLACEMENT).....\$45.00

RESIDENTIAL PERMIT -- BASIC FEES:

Base fee (permit includes 2 inspections) PLUS\$100.00
 Partial Inspection\$50.00
 Rejection Fee\$50.00
 Permit Transfer 1/2 of original permit
 Penalty for Work without Permit.....\$100.00

FIXTURE FEES:

Including, but not limited to, each vent, stack, trapped fixture, water supply distribution system, domestic water heater, interior storm leader, storm and/or sanitary pumping system, plumbing fixtures, floor drains, sewage ejectors, water line \$6.00

COMMERCIAL PERMIT -- BASIC FEES:

*Base fee (permit includes 4 inspections) PLUS\$225.00
 Each additional inspection \$50.00
 Commercial UNIT Fees (apartments & condos)\$15.00 (per unit)
 Rejection Fee\$50.00
 Minor Commercial Permit.....1/2 of permit + fixtures
 Permit Transfer 1/2 of original permit
 Penalty for Work without Permit.....\$200.00

FIXTURE FEES:

Including, but not limited to, each vent, stack, trapped fixture, water supply distribution system, domestic water heater, interior storm leader, grease trap, storm and/or sanitary pumping system, interior roof drains, plumbing fixtures, floor drains, sewage ejectors, water line..... \$10.00

*Commercial base fee is for each unit or suite for condos, townhouses, retail or rental buildings; base fee is not applicable to individual apartment units but would include plumbing system inspection for entire building.

Commercial Plan Review Fees:

1-49 fixtures.....\$100.00
 50 or more fixtures.....\$200.00

MEDICAL GAS PERMIT -- BASIC FEES:

Contractor Registration.....\$100.00
 Base Fee (permit includes 4 inspections) PLUS\$250.00
 per each medical gas outlet\$10.00
 per each zone valve assembly\$25.00
 per each new system tie-in to existing system\$25.00
 per each new system (example: Nitrous, Oxygen)..... \$25.00 per system
 Reinspection/Rejection fee.....\$100.00
 After Hours Inspection Fee.....\$300.00 minimum for 1st 3 hours or
 less + \$100.00/hour after 3 hours

Penalty for Work without Permit.....\$300.00
